AMENDMENT 1

Page 1, Scope

Replace the 3rd and 4th paragraphs of the Scope by the following:

It is applicable to

- tower cranes that can be assembled and dismantled (by element or self-erecting cranes),
- permanently erected tower cranes, and
- mobile self-erecting tower cranes.

It is not applicable to

- mobile cranes, or
- erection masts, with or without jibs.

Page 2, definition 2.1

Replace Note 3 by the following:

NOTE 3 The appliance may be installed in a fixed position or equipped with means for displacement or climbing.

Add a fourth Note:

NOTE 4 A mobile self-erecting tower crane is considered a tower crane.

Page 4, Table 1

Add a line to the table, for mobile self-erecting tower cranes:
